

Speaker: The Hon Margaret Ng

Margaret Ng is a member of the Legislative Council of the HKSAR elected by the Legal Functional Constituency. She has held the LegCo seat from 1995 to the present with a break between 1 July 1997 – 30 June 1998. In that position she has participated in the scrutiny and enactment of legislation in the area of intellectual property including copyright, patents and trade marks. She is currently the Chairman of LegCo's Panel of Administration of Justice and Legal Services. Miss Ng is a barrister in private practice.
